- Under the general direction of the Section Administrator and senior environmental specialists, acts as point of contact in scheduling field and office reviews including meetings of projects.
- Performs field work to develop Historic Property Reports and support approval of Section 106 documentation.
- Prepares and maintains records of investigations and other work, updates division project tracking system as necessary for assigned area/projects.
- Provides technical assistance and assists in conducting special program studies.
- Assists in development of strategies to accomplish INDOT's historic/architecture and historic bridge program objectives, develops survey methodology & analysis techniques.
